# REGULATIONS

1. By signing this application the applicant agrees to accept all responsibility for personal injury or damage, or for the loss or theft of clothing or equipment of the applicant, or anyone attending on the invitation of the applicant.
2. The applicant shall be responsible for the conduct and supervision of all persons admitted to the centre's building and grounds and shall see that all regulations contained in this permit are strictly observed.
3. Rooms may be used for meetings, classes, educational and cultural purposes. The nature, philosophy and mission of the agency, organization or activity must be in no conflict with Christian values and principles.
4. Users cannot change the HVAC temperature setting. Users shall turn off the lighting after use.
5. All exits and driveways must be kept free from obstruction in case of fire.
6. The applicant must pay all damage arising from use of centre's property and or equipment.
7. Alcoholic beverages must not be brought in or consumed on any part of the centre's premises.
8. No smoking on centre's premises.
9. Games of chance, lottery, or gambling in any form are strictly forbidden.
10. Food and drinks are allowed in the designed area only. Those area will be indicated by centre's officials or prescribed in the permit.
11. No utterance of an obscene or disloyal nature will be permitted.
12. It shall be the responsibility of the applicant to see that all persons admitted to the function being held, have vacated the centre building and grounds promptly on the time specified on the permit as approved.
